## ADMIT ONE EMERGENCY NURSING 2024 GIVEAWAY OFFICIAL RULES ("OFFICIAL RULES")

The "Admit One Emergency Nursing 2024 Giveaway" (the "Giveaway") is sponsored by the Emergency Nurses Association ("Sponsor"). This Giveaway is governed by these Official Rules. By participating in the Giveaway, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the Giveaway, as determined by the Sponsor and its agents, are final in all respects. The Giveaway is subject to all federal, state, and local laws and regulations and is void where prohibited by law.

1. **ELIGIBILITY:** Only persons 18 years and older at the time of entry. Persons must register for both Emergency Nursing 2024 and have reserved a room within the ENA housing block at The Venetian Resort Las Vegas. Only persons who expect to attend Emergency Nursing 2024 in person as a full-conference participant are eligible ("Entrant(s)"). Entrants may enter the Giveaway once. ENA employees, officers, and directors of Sponsor (including, without limitation, its respective affiliates and subsidiaries), along with their immediate family members and/or those living in the same household of each such person, are not eligible to win the Giveaway. Entrants may only win one Prize during the Giveaway.

2. **HOW TO ENTER:** There is no entry fee, and no purchase is necessary to enter or win this Giveaway. The Giveaway begins at 12 AM CST on Wednesday, May 8, and ends at 11:59 PM CST on Thursday, August 8 ("Submission Period"). Entrants enter the Giveaway by registering for [Emergency Nursing 2024](#) and reserving a hotel room within the ENA room block at [The Venetian Resort Las Vegas](#) (the "Submission"). One entry per person. All Submissions must be received during the Submission Period. Sponsor reserves the right to extend or shorten the Giveaway at its sole discretion.

3. **SUBMISSION REQUIREMENTS:** All information included in the Submission must be the complete and accurate information of the Entrant. Submissions not in compliance with the submission requirements outlined in these Official Rules (as determined by the Sponsor in its sole discretion) may not be considered.

Sponsor is not responsible for lost, late, unreadable, unplayable, corrupt, unqualified, or incomplete Submissions, or Submissions not received for any reason. Submissions will not be acknowledged.

4. **WINNER SELECTION:** Up to three (3) winners will be chosen at random at the close of the Submission Period from all qualified Submissions. Submissions that do not comply with these Official Rules are subject to disqualification. The Sponsor's decision regarding all matters of the Giveaway, including, without limitation, whether a Submission is qualified, will be final and binding and no discussions will be entered into with respect thereto.

5. **PRIZE DESCRIPTION:** Each winner will receive, at random, one item from the following list (each item a "Prize" and collectively the "Prizes"):

The Sponsor will notify each winner when and where their Prize can be collected. ALL TAXES ARE THE SOLE RESPONSIBILITY OF THE WINNERS. The Prizes are awarded without warranty, express or implied, of any kind. **6. WINNER NOTIFICATION:** Winners will be notified within 14 days after the end of the Submission Period. The inability to contact a winner may result in disqualification and selection of an alternate winner. If the winner cannot be contacted or does not claim their Prize within 14 days of notification or is not qualified to win, the Sponsor reserves the right to withdraw such Prize from the winner and choose a replacement winner.

**7. CONDITIONS OF PARTICIPATION:**

a. No transfer, assignment, or substitution of any Prize permitted, except Sponsor reserves the right to substitute any Prize (or prize components) for an item of equal or greater value at Sponsor's sole discretion.

b. All federal, state, and local laws and regulations apply. Entrants agree to be bound by the terms of these Official Rules and by the decisions of the Sponsor, which are final and binding on all matters pertaining to this Giveaway.

c. By entering, Entrant grants to Sponsor and its affiliates a nonexclusive, worldwide, irrevocable, royalty-free license to edit, publish, promote, and republish at any time in the future and otherwise use Entrant's name, likeness, statements, biographical information, and any other information provided by Entrant, in any and all media for possible editorial, promotional, or advertising purposes, without further permission, notice, or compensation (except where prohibited by law).

d. By entering and/or accepting a Prize, Entrants and the winners agree to hold and indemnify the Sponsor, and its respective subsidiaries and affiliates, promotional partners, directors, officers, and employees harmless for liability, damages, or claims for injury or loss to any person or property, relating to, in whole or in part, directly or indirectly, participation in this Giveaway, the acceptance and/or subsequent use or misuse or condition of the Prize awarded, or any claims including but not limited to claims based on publicity rights, defamation, invasion of privacy, or copyright infringement. False or deceptive entries or acts will render the Entrant ineligible. If such information is discovered by the Sponsor after a winner has received notice of winning and before a Prize is awarded, the Sponsor may rescind such Prize in its entirety. Decisions of the Sponsor are final and binding in all matters related to

this paragraph. Sponsor is not responsible for any typographical or other error in the printing of the offer, administration of the Giveaway, or in the announcement of the Prizes.

**9. CONDUCT:** All Entrants agree to be bound by these Official Rules. Sponsor, in its sole discretion, reserves the right to disqualify any person they find to be tampering with the entry process or operation of the Giveaway website or that they find has otherwise violated these rules.

**10. LIMITATIONS OF LIABILITY:** Sponsor is not responsible for lost or late Submissions nor for electronic-transmission errors resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone-equipment, electronic, computer, hardware, or software malfunctions or limitations of any kind, or inaccurate transmissions of or failure to receive entry information by Sponsor or presenter on account of technical problems or traffic congestion on the Internet or at any website or any combination thereof. If for any reason the Internet portion of the program is not capable of running as planned, including infection by computer viruses, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes that corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Giveaway, the Sponsor reserves the right at its sole discretion to disqualify any individual who tampers with the entry process and to cancel, terminate, modify, or suspend the Giveaway. Sponsor reserves the right to select winners from eligible entries received as of the termination date. **CAUTION:** Any attempt by an Entrant to deliberately damage any website, Sponsor's intranet or undermine the legitimate operation of the Giveaway is a violation of criminal and civil laws and should such an attempt be made, Sponsor reserves the right to seek damages from any such Entrant to the fullest extent of the law.
