

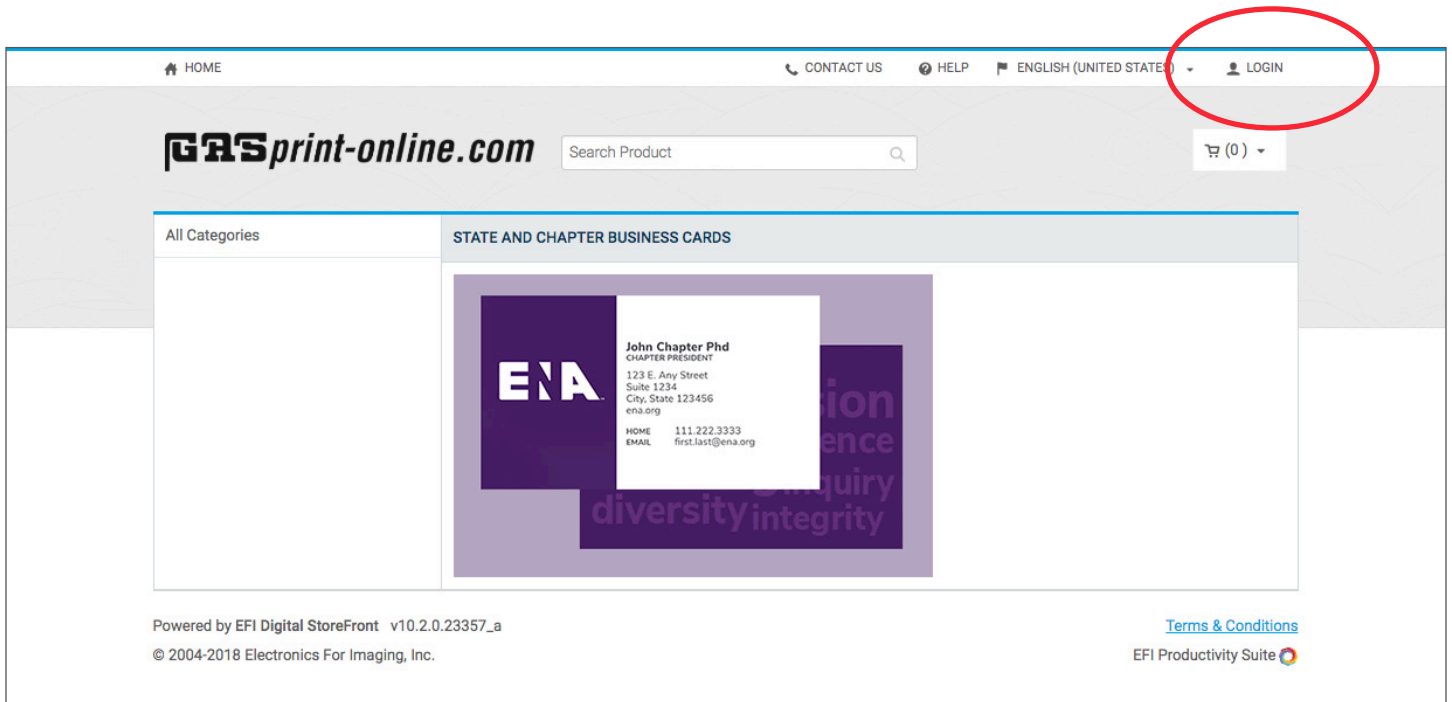

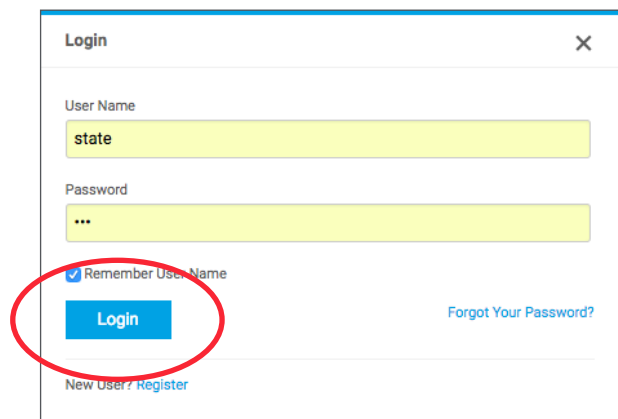
First login by using your unique User ID and password listed on pages 8–9. You can also choose to create your own User ID and password.

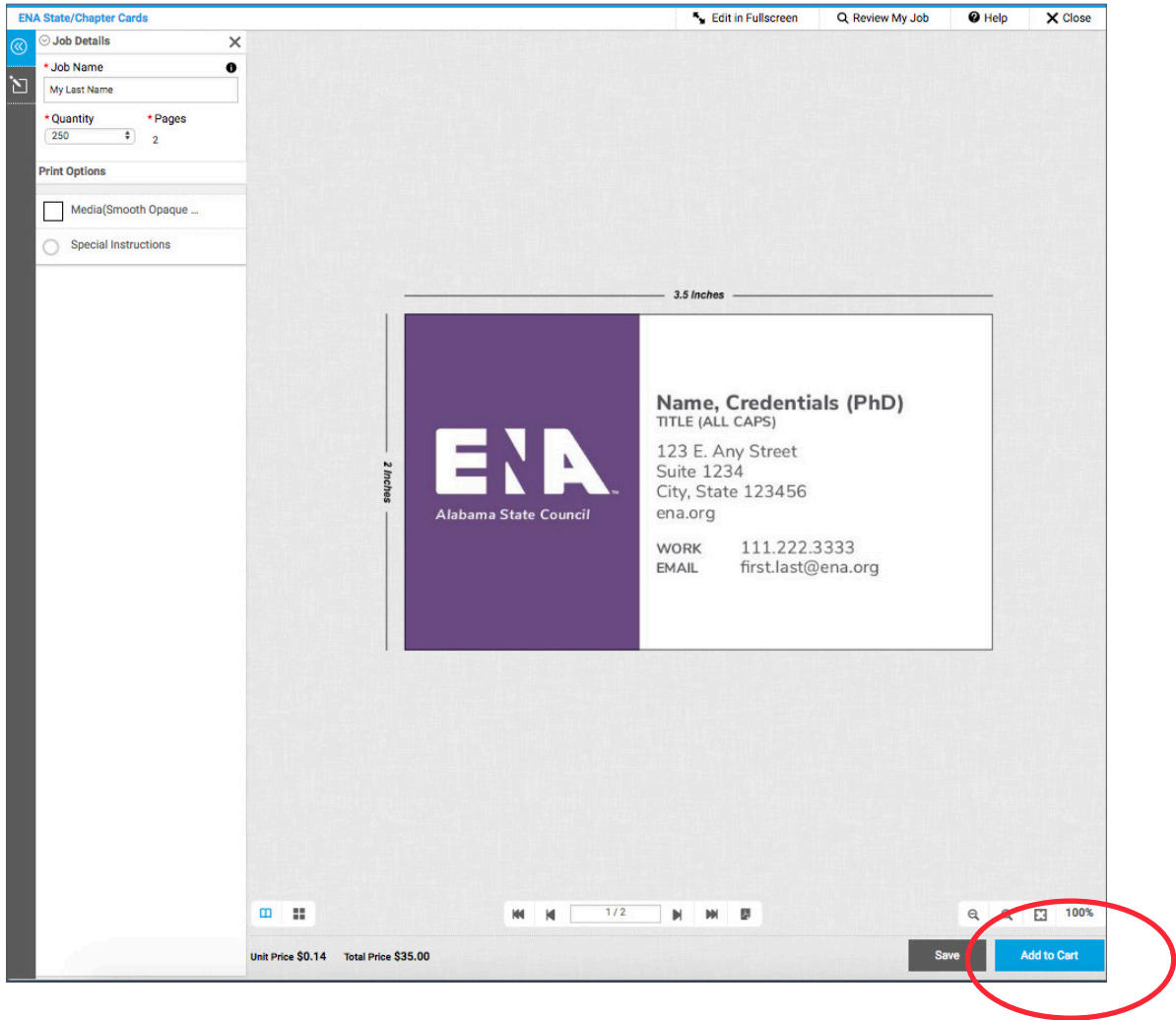

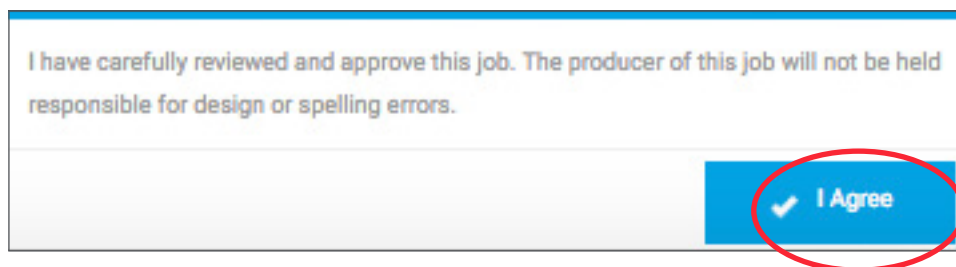

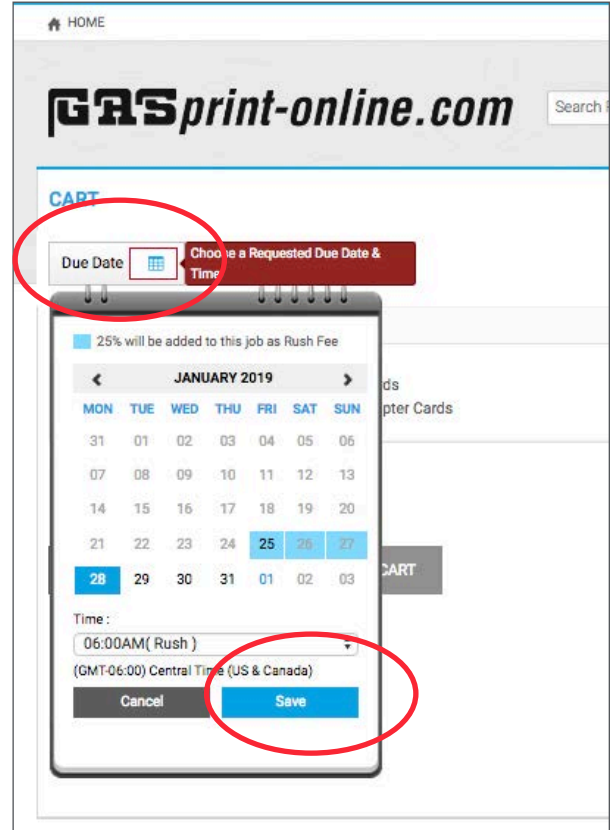
The following approval screen will come up, if you are satisfied with the proof of your business card, click on the **“I Agree”** button.



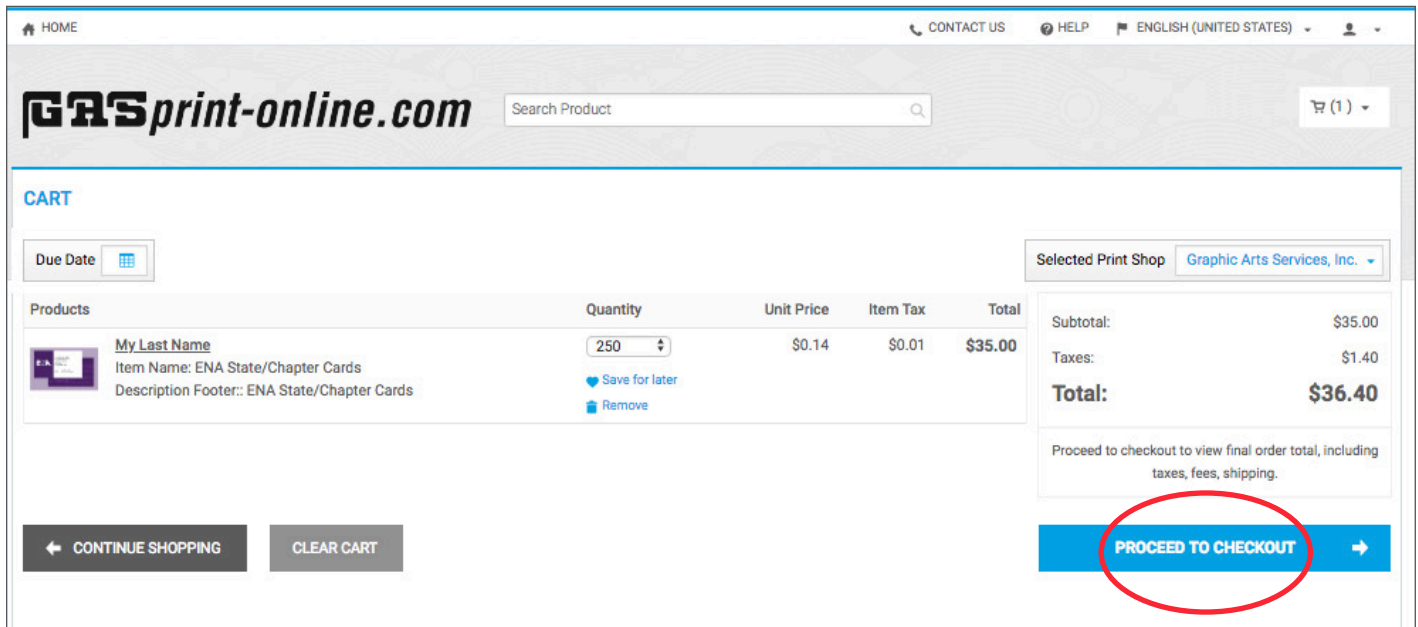
